

## **Individual Market – 2017**

### **General Information:**

The Bureau of Insurance has identified the carriers on the attached list as having one or more health benefit plans approved to be offered in Virginia's individual market. Please be aware that:

- A carrier might not offer health benefit plans in all areas of Virginia;
- A carrier may restrict enrollment to open enrollment or special enrollment periods;
- Certain other restrictions may apply.

### **Definitions:**

As used in the attached list, "**Product Type**" abbreviations and the term "**Federal Health Insurance Marketplace**" have the following meanings:

- \* **EPO (Exclusive Provider Organization) Product** – A type of product underwritten by an insurance company that provides health care coverage for services rendered only through a specified network of hospitals, doctors and other health care providers, except in emergency situations.
- \* **HMO (Health Maintenance Organization) Product** — A type of product underwritten by a company licensed as a Health Maintenance Organization or HMO that provides health care coverage for services rendered only through a specified network of hospitals, doctors and other health care providers, except in emergency situations.
- \* **POS (Point-of-Service) Product** – A type of product underwritten by a company licensed as an HMO that provides health care coverage for services rendered through a network of participating hospitals, doctors and other health care providers and *out-of-network providers*. Typically, a POS requires the policyholder to pay higher costs when he seeks care from an *out-of-network provider*.
- \* **PPO (Preferred Provider Organization) Product** – A type of product underwritten by an insurance company that provides health care coverage for services rendered through a network of participating hospitals, doctors and other health care providers and *out-of-network providers*. Typically, a PPO requires the policyholder to pay higher costs when he seeks care from an *out-of-network provider*.
- \*\* **Federal Health Insurance Marketplace** – Also known in Virginia as the Federal Health Benefits Exchange. For information about the Federal Health Insurance Marketplace for Virginia, please refer to [www.healthcare.gov](http://www.healthcare.gov).
